## Terms of the campaign "5000 idcoin for joining the IDsalary package"

## 1. General Provisions:

- 1.1 **Campaign:** a campaign conducted by "ID Bank" CJSC (hereinafter, the Bank) from 20.09.2024 to 31.12.2024 inclusive.
- 1.2 **Card:** a new card issued by "ID Bank" CJSC as part of the IDsalary package, ordered during the Campaign and having an active status. Before the start of the Campaign, Cardholders of cards operating within the IDsalary package do not participate in the Campaign.
- 1.3 Cardholder: Cardholder of the Card issued within the Campaign.
- 1.4 **Idcoin:** a digital loyalty unit that is accumulated in the Idram&IDBank application and the Idplus loyalty platform. It can be used by making a QR payment on the Idram&IDBank application and on the Idplus loyalty platform.
- 1.5 **QR payment:** QR payment made by the Cardholder in the Idram service network. In addition, the sum of QR payments made by the Cardholder with all accounts in the Bank will be taken as a basis.
- 1.6 By participating in the campaign, the client unconditionally accepts these Terms and Provisions, which are considered final and indisputable.

## 2. Terms of Campaign:

- 2.1 During this Campaign, from 20.09.2024 to 31.12.2024 inclusive, both existing and new customers will receive 5000 idcoins (taxed) upon ordering a Card within the IDsalary package, if the following conditions are met at the same time:
- They will ensure the receipt of a salary of at least AMD 75,000 to the Card within 50 calendar days after the activation of the Card.
- They will make a QR payment of at least AMD 5,000 within 50 calendar days after the activation of the Card.
- 2.2 A maximum of 5000 idcoins are provided to the Cardholder during this Campaign.
- 2.3 idcoins will be provided periodically up to 19.02.2025 inclusive within 10 business days after meeting the terms of this campaign.
- 2.4 Customers participate in the Campaign automatically; no additional action is required.
