Terms and conditions for implementation of campaign «3000 idcoin for synchronization»

1. General provisions.

- 1.1 **Campaign** a campaign implemented by "ID Bank" CJSC (hereinafter the Bank) from 08.07.2024 to 30.09.2024 inclusive.
- 1.2 **Card** any card issued by "ID Bank" CJSC, which was ordered during the Campaign and has an active status. Moreover, the Card can be ordered through the Idram&IDBank application, idbanking.am, Banking.idram.am platforms, as well as through the Bank's branches or the website <u>www.idbank.am</u>.
- 1.3 **Existing customer** a customer of the Bank who has an existing account/product/service before the synchronization of Idram and Bank accounts through the Idram&IDBank application (idbanking.am or Banking.idram.am platforms).
- 1.4 **idcoin** a digital loyalty unit that accumulates in the Idram&IDBank application and the Idplus loyalty platform. It can be used in the Idram&IDBank application and by making a QR payment on the Idplus loyalty platform.
- 1.5 By participating in the campaign, the customer unconditionally accepts these Terms and Conditions, which are considered final and indisputable.

2. Terms of Campaign

- 2.1 The following customers of the Bank will receive 3000 idcoins within the framework of the campaign, from 08.07.2024 to 30.09.2024 inclusive:
 - Existing customers of the Bank who will synchronize their Idram and Bank accounts during the campaign through the Idram&IDBank application, idbanking.am or Banking.idram.am platforms.
 - New customers who will register in the Idram&IDBank application, idbanking.am or Banking.idram.am platforms during the campaign and synchronize their Idram and Bank accounts and order Card(s) within 15 calendar days. Other terms and conditions of issuing and maintaining of cards are defined in the information summaries of the respective cards.
- 2.2 Each Customer will receive a maximum of 3000 idcoins during this Campaign.
- 2.3 ideoins will be provided regularly until 10.10.2024 inclusive, within 10 working days after meeting the terms of this Campaign.
- 2.4 Customers participate in the Campaign automatically, and no additional action is required.
