Terms of the Campaign «15% idcoin on Children's day»

1. General Provisions:

- 1.1 **Campaign**: a campaign conducted by "IDBank" CJSC (hereinafter, the Bank) from 28.05.2025 to 15.06.2025 inclusive.
- 1.2 **QR payment:** QR payment made by individuals in the service network of Idram LLC (hereinafter referred to as Idram) using the Idram&IDBank application (including the idplus application), as well as Idram payments made using NFC, QR technology and on online websites.
- 1.3 **idcoin:** a digital loyalty unit that is accumulated in the Idram&IDBank application and the Idplus loyalty platform. It can be used by making a QR payment on Idram&IDBank application and on Idplus loyalty platform.
- 1.4 **Customer**: any user who will make a QR payment with the ldram&IDBank application (including the idplus application) at the children's entertainment centers listed below.
- 1.5 By participating in the Campaign, the customer unconditionally accepts these Terms and Provisions, which are considered final and indisputable. By participating in the campaign and accepting idcoins, individuals who are not clients of "ID Bank" CJSC give their agreement to the transfer of their personal data to "ID Bank" CJSC for the purpose of calculating and paying income tax.

2. Terms of Campaign:

- 2.1 Within the framework of the campaign, from 28.05.2025 to 15.06.2025 inclusive, Customers will receive 15% instant idcoin (including taxes) by making QR payments at the following children's entertainment centers:
 - Yerevan Park
 - Haghtanak Park
 - Captain Kid's Treasure Island Yerevan Mall
 - Magic Land Erebuni Mall
 - Magic Land Mega Mall
 - Magic Land Mashtots 5
 - Play Lab Dalma Garden Mall
 - Game Lab Rio Mall
 - Alby Land Homeplex Mall (after launch)



- 2.2 In the case of QR payments, the basis for receiving idcoin will be payments made with bank accounts, attached cards, wallets, idplus accumulated bonuses/gift cards, idcoin, combo option, rocket line/rocket line 0%.
- 2.3 A maximum of 5,000 idcoin (after tax) in total will be provided to a customer during this Campaign. The idcoin subject to actual receipt is provided to the Customer after deducting 20% income tax as defined by the RA legislation. All necessary taxes payable to the state are paid by the Bank.
- 2.4 Participation in the Campaign by Cardholders is automatic and no additional action is required.
- 2.5 The Bank has the right to unilaterally amend these terms and conditions at any time and apply the amendment immediately after publishing it on the Bank's official website.
