Terms of the Campaign «30% instant idcoin at outdoor swimming pools»

1. General Provisions:

- 1.1 **Campaign:** a campaign conducted by "IDBank" CJSC (hereinafter, the Bank) from 15.06.2025 to 31.08.2025 inclusive.
- 1.2 **QR payment:** QR payment made by individuals in the service network of Idram LLC (hereinafter referred to as Idram) using the Idram&IDBank application (including the idplus application), as well as Idram payments made using NFC, QR technology and on online websites.
- 1.3 **idcoin:** a digital loyalty unit that is accumulated in the Idram&IDBank application and the Idplus loyalty platform. It can be used by making a QR payment on Idram&IDBank application and on Idplus loyalty platform.
- 1.4 **Customer**: any user who makes a QR payment using the Idram&IDBank app (including the idplus app) in the pools included in the list below.
- 1.5 By participating in the Campaign, the customer unconditionally accepts these Terms and Provisions, which are considered final and indisputable. By participating in the campaign and accepting idcoins, individuals who are not clients of "ID Bank" CJSC give their agreement to the transfer of their personal data to "ID Bank" CJSC for the purpose of calculating and paying income tax.

2. Terms of Campaign:

- 2.1 As part of the campaign, from 15 June 2025 to 31 August 2025 inclusive, Customers will receive 30% instant idcoins when making QR payments at the following swimming pools:
 - Aquatek Sports Complex Swimming Pool
 - Cross Sports Complex Swimming Pool
 - Dili Town Resort Swimming Pool
 - Garun Swimming Pool at the Dilijani Tun Hotel
 - Hills Sports Complex Pool
 - Swimming pool at Lanj Restaurant
 - Swimming pool at Multi Wellness Center Sports and Health Complex
 - San Marco Pool
 - Swimming pool at the President Hotel
 - Zen Pool
- 2.2 In the case of QR payments, the basis for receiving idcoin will be payments made with bank accounts, attached cards, wallets, idplus accumulated bonuses/gift cards, idcoin, combo option, rocket line/rocket line 0%.



2.3 As part of the campaign, one customer can receive a maximum of 10,000 idcoins per calendar month (after tax). The idcoin subject to actual receipt is provided to the Customer after deducting 20% income tax as defined by the RA legislation. All necessary taxes payable to the state are paid by the Bank.

2.4 Participation in the Campaign by Cardholders is automatic and no additional action is required.

2.5 The Bank has the right to unilaterally amend these terms and conditions at any time and apply the amendment immediately after publishing it on the Bank's official website.
