Transfer modification/Change of bank details	 The transfer can be modified free of charge on the day of submitting a relevant application based on a written request and ID document presented by the sender at the service center, where the transfer was executed; The transfer modification is made through a procedure established by the system; Only the recipient's data (name, last name, patronymic) can be changed; Only unexecuted transfers can be modified. 		
Transfer cancellation	 The transfer can be cancelled without additional charges, based on a relevant cancellation form and passport details, submitted by the sender on the same day when the transfer was executed; both the transferred amount and the commission shall be refunded. Only unexecuted transfers can be cancelled. 		
Transfer recall	 The transfer can be recalled based on a written request of the client within one banking day or later. 		

	 The commission is refunded by the system depending on the reason for the refund of the transferred amount. Only unexecuted transfers can be recalled.
Expiry period of transfers	21 days

Transfers through Ria Money Transfer system can be made at any branch of "ID Bank" CJSC.
